Chronic truants are students who are absent from school without valid cause for 18 or more of the last 180 school days.

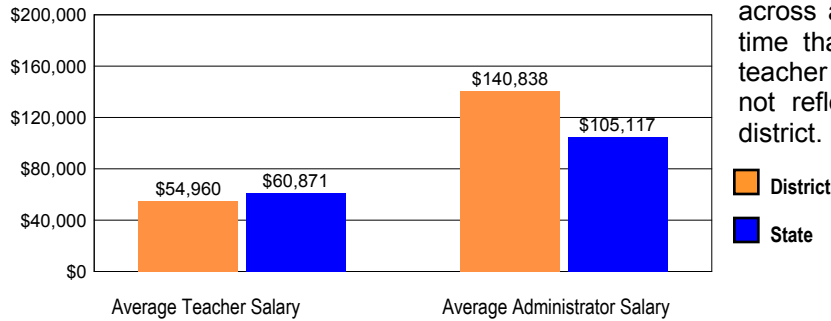

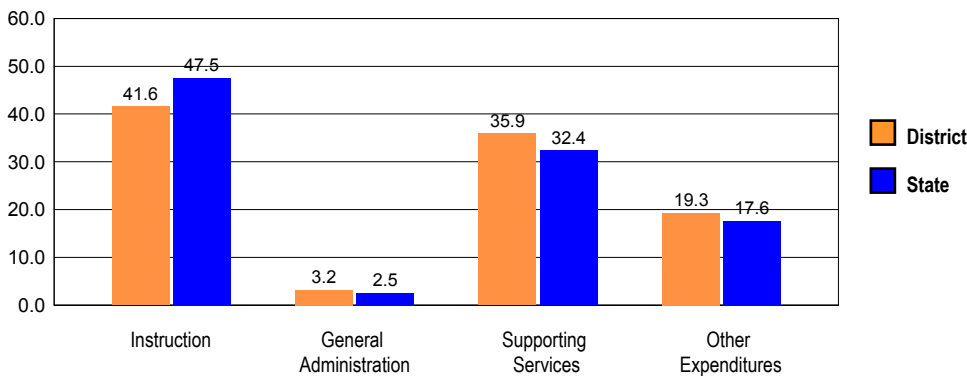
SCHOOL DISTRICT FINANCES
